2.2 Terms :

Acre	A unit for measuring land area. (Acre equals 4840 Square yards).
Bhoodan Land	Land donated in charity by original land owners for the benefit of the poor. These lands are controlled by a Board called Bhoodan Board. Bhoodan Board allots Bhoodan lands to poor persons for cultivation. Descendants of Bhoodan allottees also have right of succession to such lands.
Development Block	A number of villages grouped together form a & Panchayat Samiti Development Block. Local Self-governing body at Block level is Panchayat Samiti.
District Collector	Administrative head of a District.
Divisional Commissioner	Administrative head of division comprising a number of districts.
Ghair Khatedars	Include allottees, holders of "Muafi lands"
Hectare (Ha)	A unit measuring land area. One Hectare equals 10,000 Sq. meters & also one Ha. equals 2.475 Acres.
Jamabandi	Basic record of land rights.
Khatedar or tenants	According to Law, all land belongs to the State and all so called land owners are tenants of the State. They are called Khatedars.
Muafi Lands	Include lands attached with Temples, Mosques, Gurudwara, Churches etc. where Priests/Pujaris are allowed to cultivate the same without having to pay revenue charges for the same.
Murabba	A square piece of land measuring 825 ft. x 825 ft. (275 yards x 275 yards).
Panchayat	Elected local self-governing body at village level.
Poverty Line	A family whose annual income from all sources is less than Rs. 20,000/-is considered to be below Poverty Line.
Pradhan	Elected head of a Panchayat Samiti.
Sub-Tenants	Persons, who not being tenants, are allowed to cultivate land on certain terms & conditions.
Share-Croppers	Persons who cultivate land of a Khatedar on terms of sharing income therefrom with the Khatedar.
Zila Parishad	Zila Parishad is an elected self- governing body at District level
Zila Pramukh	(above the block level) mainly for development works of rural areas through Panchayat Samitis and Panchayats. The elected head of Zila Parishad is Zila Pramukh.
