

ORDER

In pursuance of para 29, 30 of Common Guidelines for Watershed Development projects issued by Department of Land Resources, Ministry of Rural Development, New Delhi w.e.f. 01.04.2008 and FD's approval vide ID No. 2671 dt. 18.12.08, the approval of State Government is hereby issued to designate Executive Engineers (Land Resources), working in the Zila Parishads as Project Manager, District Watershed Development Unit (DWDU) for their respective districts.

They will be exclusively responsible for implementation of all watershed development schemes in districts as per Common Guidelines. Additional staff for the strengthening of DWDUs would be sanctioned after receipt of required funds from DoLR, MoRD, Govt. New Delhi.

The above mentioned Executive Engineer (LR) cum Project Manager DWDUs are authorized to open a separate independent bank account in the name of Project Manager, DWDU of concerned district in the local branch of State Bank of Bikaner and Jaipur. Project Manager, DWDUs are also authorised to operate these bank accounts. They will work under the SLNA as per the Common guidelines for Watershed Development.




